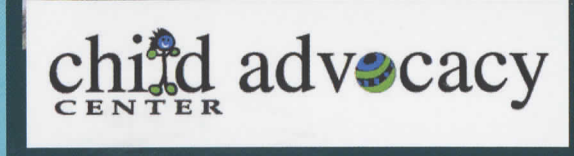

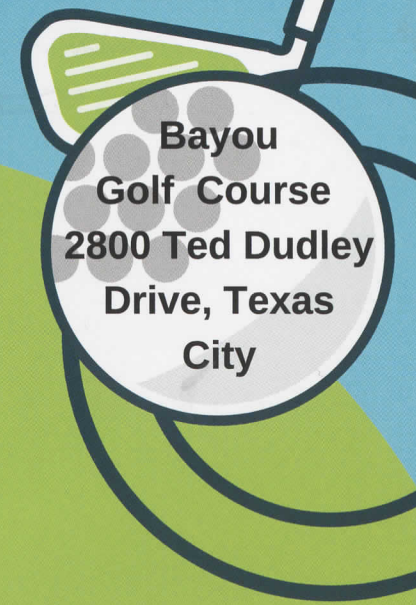

Services Offered at the Center

- Forensic Interviews by specially trained interviewers.
- Weekly case staffing with the DA's Office, Law Enforcement, CPS and medical staff to review new cases for criminal charges.
- Trauma Focused therapy for child victims and their non-offending family members.
- Case management for the life of a case, ensuring children don't fall through the cracks of the system.
- Medical exams by specially trained doctors and nurses.
- Case coordination, assisting in timely intervention, coordination of investigative agencies and service scheduling.
- Prevention and Education programs for the community and other professionals.

All services at the Center are provided at no cost to the clients.

The Advocacy Center for Children is a non-profit that helps coordinate the investigation, prosecution and treatment of child abuse cases. The goal of the Center is to reduce the trauma of abuse on children by providing a coordinated investigation, quality interviews, crisis therapy and expert medical exams. Abused children who get help early are more likely to succeed in coping and have a better chance to become healthy adults and good parents to their own children.

Undefeated MC is a law enforcement motorcycle club dedicated to improving and supporting the communities in which they live. they support a variety of charitable groups and have raised over \$100,000 for the Advocacy Center. Andy McLane was one of the founding members of Undefeated MC and was a long-time supporter of the Advocacy Center.
